This information bulletin provides details of the insurance companies approved for workers' compensation purposes in the Northern Territory.

Requirement for employers

Under the [Workers Rehabilitation and Compensation Act](#), employers **MUST** hold a workers' compensation insurance policy with an approved insurer if:

- They employ a person who provides work or service for them and **does not** provide the employer with an [Australian Business Number \(ABN\)](#) in writing; or
- The employer is based outside of the Northern Territory and has persons providing work or service for the employer within the Northern Territory and those persons **do not** provide the employer with an [Australian Business Number \(ABN\)](#) in writing.
